New Protocols

A. M419 Pediatric Sepsis

Discussed change from 1 L to match adult dose of 500 ml. Goal for this is to have consistency between adult and pediatric protocols and to have a set volume that hospitals can infuse without stopping EMS fluids and document what the patient got to meet guidelines.

B. SB201 ALOC/Syncope

See handout from Joe Stoffolano with development of this protocol. Joe included syncope and pre-syncope definitions, flow chart and noted importance of cardiac monitoring (see C). A lot of discussion over title, Altered Mental status vs level of consciousness. Joe to change title and will bring back to next meeting for final approval.

C. End-of-Life Care/Palliative Care

Looking for new education to come down from the state after Labor Day. Discussion about valid or non-valid DNR forms. If something is hand written on the DNR form in addition to the original form, what is added is invalid not the entire form itself; committee discussed adding in a note to call medical direction if anything is supplemented by hand writing on the form. Will add new form to appendix section of protocol and include state presentation in the new protocol training.

D. OB and GYN

Imminent Delivery- Adjustments were made from last meeting, took out evidence to make more directional for treatment. Included examples of high level NICUS and took out the administration of O2 so it didn't look different from O2 admin is the rest of the protocol. We are hoping to add NICU capabilities to hospital capabilities survey, will bring back to EDS committee. Pregnancy complications- Discussed keeping benzos as first line for seizures, changed Mag admin for HTN from 6 grams to 4 grams. Inclusion criteria need updating in pregnancy complications. Approval will come next meeting with changes and Chief Gallo to re-format.

Protocol Updates/Revisions

A. P612 Pediatric Pain Management

Changed the bolus amount to 500 mL. Need to add in notes and training presentation that it's appropriate to give Tylenol and Fentanyl concurrently.

B. M411 – Glucagon and Calcium Gluconate dosing & Conflicting narcan doses in M411 and P611

Toxicology protocols for adults and pediatrics combined. Phone numbers for local and national poison control were revisited and listed. Will switch order to put local number first. Discussion over "one pill can kill age", will discuss on why 6 was chosen and not 12 (Lauren to discuss with Michelle) Narcan dosing needs to match pre-dosed atomizers.

C. <u>\$500, T701, T710 Updates</u>

Included info for Tension Pneumo/Needle Decompression from CCHMC. APPROVED.

D. S506 -TXA

Reviewed updates. APPROVED.

E. TXA Checklist

Chief Gallo updated to include CCHMC suggestions. Change needs to happen to mg instead of ml (for 100 ml). **APPROVED.**

F. Defib Dosing

Included recommendations from the manufactures. Will bring draft to next meeting.

G. Trauma Triage

Will have to create word version in order to edit due to it being a PDF picture. Will move open skull fractures and near drowning to anatomy of injuries. Will change geriatric age to be consistent with our protocol.

New Business

A. Update Epinephrine throughout protocol to reflect the correct labeling.

B. P603 – CHMC trauma services requested that the 3% dosing for peds be changed to 4 ml/kg instead of 8 ml/kg. **APPROVED.**
